Under authority granted to me by the Southern California Association of Governments (SCAG) Regional Council, I hereby approve and transmit amendment #15-01 for projects in Imperial, Los Angeles, Orange, Riverside, San Bernardino, Ventura, and Various Counties. This amendment:
