

**Defensible Space and Fuel Reduction** slow momentum and intensity of Fire Front.




Scar above Westlake Village Community. 0 Structures lost.

## Home Hardening: Ember Basics

### Zone 0: 0-5 ft

- Embers accumulate within this zone
- Combustibles within this zone vulnerable to ignition
- Home maintenance:
  - Chipped paint / damaged materials
  - Vent screening
  - Combustible Siding (w/i 6-in of the ground)





# Influencing Programs & Grant Applications

“The following are the VRFSC fuel reduction priorities:


1. Continue to partner with local agencies and groups to conduct fuels reduction projects throughout the county.
2. Seek grant funding to contract fuels reduction priority projects.
3. Provide education about fuel reduction treatment types” (CWPP, 57).

## What role can you play in wildfire planning? More on Plans

- While the Safety Element of General Plans and Local Hazard Mitigation Plans are mandated, many agencies and nonprofits are writing **Community Wildfire Protection Plans and Regional Priority Plans** to qualify for common wildfire mitigation funding streams (CAL FIRE, USFS, and CA Department of Conservation)
- **Support needed:**
  - Insights, direction, and communication regarding *expansion in the Wildland Urban Interface*
  - *Alignment with climate resilience goals* (mulch for drought resilience, urban greening, etc.)
  - *Consistency with fire agencies* in code and permitting requirements
  - *Influence and educate* the public: residential and community solutions
